## **INSTRUCTIONS FOR PROBATE**

- File two (2) copies of Inheritance Tax Return with the Register of Wills office
- File one (1) copy of Inventory with Register of Wills
- Pay Inheritance Tax due to avoid accruing penalties and interest Note: Inheritance Tax Return and payment must be hand delivered to the office or postmarked with nine months of the date of death
